The Authority, vide Public Notices referred above, had conveyed that the Authority had developed its Web based online system and directed the Promoters to upload the details of Projects already registered in the Web Portal by 31/05/2021, as per the provisions specified under Section 11 of the Real Estate (Regulation & Development) Act, 2016 read with Rule 17 of Kerala Real Estate (Regulation & Development) Rules, 2018.

But considering the Covid Surge and recent restrictions, the Authority hereby extends the timeline for uploading the details of already registered projects to 30/06/2021.

The "Public Search" option is also not yet opened in the new web portal, considering the difficulties of the Promoters in completing the uploading process in the current situation. But on the basis of several requests received from allottees and other end-users, the Authority has decided to open the "Public Search" option in the web portal by 01/07/2021. Only data regarding the registered projects uploaded and submitted to the Authority via Web portal will be available to the public. All the Promoters of the registered Real Estate Projects are hereby advised to upload the complete details of their projects fully and precisely as provided under Section 11 of the Real Estate (Regulation & Development) Act, 2016 read with Rule 17 of Kerala Real Estate (Regulation & Development) Rules, 2018. In this context, it is to be noted that the non-uploading of details of any projects or uploading any incomplete/incorrect data regarding the projects shall affect the credibility of such Projects and the Promoters concerned and also the marketing activities of the projects as well.
