ORDER

All enclosures mandated as per serial no: 63 of the Application and all items starred in the "CHECKLIST FOR FILING APPLICATION" shall be **duly signed** by the Promoter / Authorised signatory.
- (5) Application in Form A, Declaration supported by affidavit in Form B and details to be furnished as per serial no: 53 to 55, 58, 63 to 68 and 72 to 74 shall be submitted in legible **typed** form.
- (6) The proforma of agreement for sale to be enclosed as per serial no: 63 of Application form shall be as per Annexure A of the Kerala Real Estate (Regulation and Development) Rules, 2018.
- (7) The Declaration supported by an Affidavit as required under serial no: 76 of Application form shall be as per Form B of the Kerala Real Estate (Regulation and Development) Rules, 2018
- (8) The **demand draft** remitting the fee shall be kept in a separate cover and submitted along with the application.
