## <u>19/10/2019</u> <u>PROCEEDING/INTERIM ORDER</u>

Hearing taken up. Today, no one turned up on behalf of the respondent promoter.

Respondent partnership firm and its partner has not been complying with the previous orders of this Bench dated 01/08/2019, 28/08/2019, wherein the respondent company's Director had committed to refund the principal amount of the respondents.

Further, it is observed that there has been an inordinate delay of more than a year in these instant cases and despite repeated orders for refund of payment to the complainants and respondent partner's inability to comply with his own commitment, there has been no progress. Therefore, the Bench deems it necessary for issue of interim order under Section 36 to be read along with Section 34 (f) & Section 37 of the Real Estate (Regulation & Development) Act, 2016.

It is therefore, directed that until further order, all bank accounts of **S.D. Construction** & **Developers** and its partner namely **Sri Sanjeev Raj (PAN ACQFS2918D)** shall be frozen with immediate effect. Below are the bank account details of the promoter:-

It is further requested to IG Registration to issue directions to all DSRs/Sub-Registrars, Patna Districts not to register any property/house/apartment/plot etc. of **S.D. Construction & Developers** till further order.
