Kumar Lamba V/s Shekhar Home Developers decided by the Authority on 23.04.2019. For deciding whether a complaint is to be referred to the Authority or to the Adjudicating Officer or the complainant is to be advised to file it in the other Form, Deputy Registrar will send it to Registrar. On the basis of relief claimed in the complaint filed, Registrar will decide whether it is to be referred to the Authority or to the Adjudicating Officer. The complaints wherein refund is demanded shall necessarily be referred to the Authority.

- 7.4 Following decisions were taken in other matters that were taken up for discussion with the permission of the Chair:-
 - 7.4.1 To know the status of compliance of the provisions regarding separate account under section 4(2)(I)(D) of the RERA Act, as a sample survey, bank accounts, books of accounts and other relevant records of any ten projects will be checked and it will be ascertained whether compliance of provisions of the said section 4(2)(I)(D) and relevant rules and regulations is being made by the promoters in depositing into and withdrawing monies from separate bank account. The report will be submitted to the Authority for considering appropriate steps that may need to be taken or directions that may need to be issued for securing full compliance of the said provisions.
 - 7.4.2 A proposal shall be sent to the Government for delegation of powers of Collector under section 260(1) of the Land Revenue Act, 1956 read with section 40 of the RERA Act, to Registrar of the Authority for recovering, as arrears of land revenue, the amounts of interest, penalty or compensation ordered by the Authority or the Adjudicating Officer, as the case may be.
 - 7.4.3 Separately, a suitable proposal shall be sent to the Government for creation of the posts of Tehsildar, Nazir and Patwaris, etc. for strengthening execution/enforcement function of the Authority.

While accepting Form R-5, Deputy Registrars (Court) will get E-mail address and Mobile Number of authorized person noted thereon. When the Regulations are amended next, Form R-5 shall be modified to incorporate these details in the Form itself.
