Looking to the technical difficulties the promoters are facing today in uploading QPRs, the last date for online submission of Quarterly Progress Report (QPR) for the quarter ending on 30.09.2021 is hereby extended to 29.10.2021, without payment of any delay processing charges or penalty.

If QPR for this quarter is not submitted by 29.10.2021, it will attract a penalty under Section 61 of the Real Estate (Regulation and Development) Act, 2016 for contravention of relevant provisions of the said Act and the rules and regulations made thereunder. In addition, delay processing charges as already specified shall be attracted on delayed submission of QPR.
