Sub: Submission of Quarterly Progress Report (QPR) for Real **Estate Projects**

As per Regulation No. 11(5)(iv) of Rajasthan RERA Regulation 2024, a new tab named "Certificate showing no lien or charge on the RERA retention Account" has been added under the existing tab of Form R3. This tab is meant for uploading a certificate of no lien or charge on the RERA retention Account while submitting the Quarterly Progress Report (QPR) of the project. Therefore, the last date for online submission of QPRs for the quarter January to March, 2024 has been extended to 15.05.2024 instead of 30.04.2024, without payment of any delay processing charges or penalty.

If QPR for the quarter January to March, 2024 is not submitted by 15.05.2024, it will attract penalty under Section 61 of the Real Estate (Regulation and Development) Act, 2016 for contravention of relevant provisions of the said Act and the rules and regulations made thereunder. In addition, delay processing charges as already specified shall be attracted on delayed submission of QPR.
