Applications are invited from the eligible candidates for the Post of Member in Real Estate Appellate Tribunal in the prescribed Format as Annexed below. For details, the Real Estate (Regulation and development) Act, 2016 and Real Estate (Regulation and Development) Rules, 2017 issued in G.O.Ms. No. 115 MA&UD (H) Dept., dated 27.03.2017 may be perused. Brief details are furnished below:

**Post:**

Member in AP Real Estate Appellate Tribunal

**Number of Vacancies:**

3(Three) in the category of one Judicial member, one Town Planning Technical and one Administrative Member.

**Qualifications:**

• **Judicial Member:**

In the case of a Judicial Member he has held a judicial office in the territory of India for at least **fifteen years** or has been a member of the Indian Legal Service and has held the post of Additional Secretary of that service or any equivalent post, or has been an advocate for at least twenty years with experience in dealing with real estate matters;

• **Town Planning Technical Member:**

In the case of a Technical member, he is a person who is well-versed in the field of urban planning & development, housing, real estate development, infrastructure, economics, planning laws and possesses experience of at least **twenty years** in the field or who has held the post in the State Government in the equivalent cadre of Director of Town and Country Planning or an equivalent post in the Central Government.

• **Administrative Member:**

In the case of an Administrative member, he is a person who is well versed in the field of urban development, economics, law, Commerce, Accountancy, Industry, Management, Public Affairs or Administrative and possesses experience of at least **twenty years** in the field or who has held the post in the Central Government, or a State Government equivalent to the post of Additional Secretary to Government of India or an equivalent post in the Central or State Government.

**Age Limit:**

Shall be less than (65) years.

**Other Condition:**

Before appointing any person as Chairperson or Member, the appropriate Government shall satisfy itself that the person does not have any such financial or other interest, as is likely to affect prejudicially his functions as such member.

**Manner of selection of members of the Appellate Tribunal:**

The Judicial members and Technical or Administrative members shall be appointed by the Government on the recommendations of a Selection Committee constituted by the Government consisting of Chief Justice of High Court of the State or his nominee, Additional Chief Secretary or Principal Secretary or Special Chief Secretary to Government Municipal Administration and Urban Development Department and Additional Chief Secretary or Principal Secretary or Secretary to Government, Law Department.

**Term of office for Members:**

The Member of the Appellate Tribunal shall hold office, as such for a term not exceeding **five years** from the date on which he enters upon his office, but shall not be eligible for re-appointment. Provided further that no Judicial Member or Technical or Administrative Member shall hold office after he has attained the age of sixty-five years.
