Submission of Quarterly Progress Reports (QPRs) for Sub: Registered Real Estate Projects

In partial modification of this Authority's orders dated 01.01.2021 and 04.01.2021 and reminder circular dated 09.03.2021 on the above subject, the last date for online submission of QPRs for all earlier quarters as also for the quarter ending on 31.03.2021 is hereby extended to 31.05.2021 without payment of any delay processing charges or penalty. If QPR for any quarter, including the quarter of January-March, 2021, is not submitted by 31.05.2021, it will attract a penalty under Section 61 of the Real Estate (Regulation and Development) Act, 2016 for contravention of relevant provisions of the said Act and the rules made thereunder. In addition, delay processing charges as specified in the aforesaid orders shall be attracted on delayed submission of such QPRs.

It is again clarified that if a project has got completed, QPRs need to be submitted for all quarters upto, and including, the quarter in which the completion certificate has been obtained; and no QPRs need to be submitted for any quarter beyond that quarter.

It is also clarified that for submitting the QPRs of earlier quarters (quarters upto July-September, 2020), -

- It is not necessary to obtain and upload Forms R1, R2 or R3; and those QPRs can be submitted on the basis of whatever records or books of accounts the promoter has maintained or the QPRs he has already submitted in paper form or the Forms R1, R2 and R3 of any dates, he may have obtained near about the end of the relevant quarter for withdrawing money from RERA account of the project; and
- Part 1 (Architectural Progress as per Form R1 issued as at the end of (2)current Quarter) and Part 2 (Engineering Progress as per Form R2 issued as at the end of current Quarter) of Section IV (Status of the Project Construction/Development), Sections VII (Compliances Under the Act), VIII (Details of Real Estate Agents engaged for the Project) and IX (Miscellaneous) of the online QPR Form shall be nonmandatory.
